## **1. Application and award**

1.1 The “FCI World Championship for Rescue Dogs” is held every two years in the end of August. National organizations that would like to organize this World Championship must apply in writing to the President of the FCI Rescue Dogs Commission, at least two years beforehand.

The application must contain:

- The name of the national organization
  - The date of the World Championship
  - The venue of the World Championship
  - The name and address of the person in charge of organizing the event
- 1.2. The FCI Rescue Dogs Commission shall entrust the organization and running of the World Championship to a national organization that is a full member of the FCI. The awarding of the World Championship ensues by a majority decision taken by the FCI Rescue Dogs Commission. In the case of a tied vote, the president of the FCI Rescue Dogs Commission shall have the casting vote.
- 1.3. The national organization that is assigned to organize the World Championship shall bear full responsibility for the smooth and trouble-free running of the championship. The organizing national body shall make an application to the FCI for the awarding of the CACIT.
- 1.4. The national organizations of the FCI are to be invited to attend by the organizing national body by September of the year preceding the World Championship at the latest.
- 1.5. The amount of the registration fee is decided by the FCI Rescue Dogs Commission. The registration fee is made up of the starting fee and a contribution to the expenses for the FCI Rescue Dogs Commission.

## **2. Organisation**

- 2.1. The minutes and resolutions of the meetings of the organizing committee are to be submitted to the FCI supervisor in writing in the ensuing weeks.
- 2.2. It must publish a catalogue showing all participants, team leaders and the time schedule. The entrants shall be given catalogue numbers, which they must wear as start numbers on their backs. The most important parts of the catalogue must be drafted at least in the national language of the organizer and in English.
- 2.3. The organizer shall request, preferably with the invitation, the national organization to donate a prize in good time. The arena is to be decorated with the flags of the competing national organizations and the FCI flag throughout the event. The prizes donated can be listed in the programme. The allocation of these prizes shall be the responsibility of the organizer.
- 2.4. All results must be regularly entered on a results board easily visible to the public.

### **3. Trial Chairperson**

- 3.1. The national organization running the event shall provide for every section a qualified trial chairperson, whose work shall include, in particular:
- Technical running of the section.
  - Provision, planning and equipment of a sufficiently large trial area
  - Providing a sufficient number of qualified helpers (marshals, tracklayers, helpers, office personnel, etc.)
  - Preparing the evaluation sheets for the trial judges
  - Quick and reliable working out of the trial results to determine the winner and order of placing.

### **4. Trial grounds and course of events**

- 4.1. The Individual FCI World Championship for Rescue Dogs shall be held in accordance with the *International Trial Rules of the FCI and the IRO for Rescue Dogs Tests*. The opening and closing ceremony and the "Obedience" and "Dexterity" phases have to be carried out in an arena with a well-tended lawn.
- 4.2. There must be a covered stand to protect spectators from bad weather. Sufficient car parking spaces must be provided for competitors and spectators in front of and near the arena. A canteen must also be available, in the arena where possible, to cater for the competitors, spectators and helpers. For the spectators, there has to be a good sight to all exercises so that they can follow the exercises.
- 4.3. The tracking ground for the "Tracking" task should enable all dogs to have the same conditions. The grounds cannot be of one uniform type; alternative grounds such as meadows, fields and ground with low plants are to be used. Obstacles such as fences, ditches, etc. are permitted as long as overcoming them does not cause the dog or the handler any undue difficulties. The ground used on one day can be used again two days after. However, a competitor cannot work twice on the same track.
- 4.4. A time schedule is to be drawn up showing the presentation time for each participant. This time schedule must be compiled in such a way that every competitor has a period of at least one hour between the individual trial sections. The order of the trial sections can be different.
- 4.5. The competitors are to be allocated a training ground for tracking training which corresponds to the actual tracking ground.

- 4.6. Before commencement of the World Championship, the different national teams are to be given time for training of the different phases. The time available is to be divided among the number of national teams.
- 4.7. A veterinary check is to be carried out before commencement of the World Championship. Dogs that appear sick and are suspected of being infectious are not admissible. Bitches in season are admissible without restrictions. The veterinary check must be completed before the draw. A FCI Rescue Dog Judge must be present for the temperament check.
- 4.8. The use of E-devices within the sphere of the World Championship shall lead to disqualification, regardless of the legal situation in the organizing country. Any accusation must be accompanied by written evidence and witnesses.
- 4.9. Before commencement of the World Championship, the president of the FCI Rescue Dogs Commission shall convene a trial judges meeting to be attended by the track supervisor, trial judges and the person in charge of organization.
- 4.10. Before commencement of the World Championship, the president of the FCI Rescue Dogs Commission shall call a team leader meeting to be attended by the supervisor, trial judges and the person in charge of organization, the trial chairperson and the team leaders.
- 4.11. The phase "Obedience and Dexterity" is to be demonstrated in the arena to ensure that The desired sequence is clear to every competitor.
- 4.12. The draw for the starting order is to be conducted in public on the evening before the World Championship. The catalogue number with the lot number assigned by the draw must be made visible to all the competitors. The dog handlers from the organizing national body shall be the last to take part in the draw for the start numbers.
- 4.13. At the closing ceremony, the national rankings shall be announced. The respective national anthem is to be played for the first placed teams in all 4 disciplines.

## **5. Trial judges and the supervisor**

- 5.1. The FCI Rescue Dogs Selection Committee nominates the supervisor and the trials judges as planned by the *Guidelines of the FCI Rescue Dogs Commission for the Selection of judges for the different FCI World Championships for Rescue Dogs*.
- 5.2. The supervisor shall be responsible for compliance with all the regulations of the trial rules and the specifications. He has to be an official FCI IPO-R judge and member of the FCI Rescue Dogs Commission. The organising national body and the competitors must follow the instructions given by the chief judge in all respects.
- 5.3. The supervisor and trial judges may not come from the organizing national body.
- 5.4. If the trial judges or the supervisor do not speak the national language of the organizing national body, a translator is to be provided by the national organization running the event.

The interpreter must be familiar with the course of the trials, display knowledge of cynology and observe discretion.

- 5.5. The decision of the trial judges shall be final and undisputable.
- 5.6. The supervisor and trial judges shall be paid by the organizing national body. The corresponding rates shall be according to the FCI regulations € 0,35 per km, €35, 00 per travel day and €50,00 per judging day. Accommodation according to receipt.

## **6. Admission and registration of competitors**

- 6.1. The total number of competitors taking part in this FCI Individual World Championship shall be limited to 150 participants in total and distributed as followed:
  - 60 for area search
  - 60 for rubble search
  - 30 for tracking

If the situation requires it, the President of the FCI Rescue Dogs Commission can limit or increase the numbers in consultation with the organizer.

Each national association can send a national team consisting of up to 6 dogs registered in area search, 6 dogs registered in rubble search, 3 dogs registered in tracking. The candidates for the Universal category must be registered in the three disciplines of nose work and are part of the allowed quota per nose work discipline. It is allowed to register other competitors but as reserve, according to the places available after the closing of the entries of registrations they will be equitably taken over as competitors.

- 6.2. Each competitor must be a member of a national organization that is affiliated to the FCI or has been invited to take part by the Rescue Dogs Commission. The right of a national organization to start in the World Championship can be given according to the following principles, the application of which is left up to the national organization:
  - nationality
  - legal residence (in accordance with the FCI Statutes)
  - The dog owner must have the nationality of the country for which his/her dog will compete or must have his/her legal residence for a minimum of 12 months in the country for which he/she will compete. If the dog owner has a double nationality he/she can choose either country without any restriction. If difficulties arise, they must be referred to the FCI General Committee for final settlement.
  - No matter his/her nationality, the dog handler will not be allowed to compete for more than one country and will be authorized to handle only one dog.
  - The dog must have been registered with the studbook or the appendix to the studbook of the country for which it will compete for a minimum of 6 months.

Registration of the national team must be made through the national organization that is in charge of the selection of his team.

6.3. Each FCI NO nominates at least one main national team leader and possibly one team leader for each discipline. In addition each national organization is allowed to register reserve competitors in each discipline, who are also to be listed in the catalogue. If any of the competitor registered cannot take part because illness/accident, it may only be replaced by the competitors registered as reserve competitors.

6.4. Members of the organizing committee may not take part in the World Championship as dog handlers.

At World Championships in Rescue Dogs Competition the only dogs allowed to compete are those (regardless of their size and breed) registered with the studbooks or the appendix to the studbooks of an FCI member organisation or contract partner as well as those registered with the studbooks or appendix to the studbooks of a non FCI member organization with which the FCI has entered into a cooperation agreement of mutual recognition of studbooks (AKC, KC, CKC) (FCI Circular 33/2010)

Only dogs selected by the national organization which have successfully passed a trial according to level B in his discipline can be admitted to the World Championship .

For the Universal category only dogs selected by the national organization which have successfully passed a trial according to level B in the three different nose work disciplines can be admitted to the World Championship in category Universal.

6.4. The national organization shall send all the registrations with the names to the organizer together before the closing date for registration stated in the invitation. The registration must contain the following information:

- Name of the national organization
- Composition of the national team
- Name, address, telephone number and e-mail address of the main team leader and of the team leaders for each discipline if any.
- Name, address, telephone number and e-mail address of the competitors (substitute competitors)
- Name of the dog, breed, and date of birth, stud book number, identity mark (chip, tattoo, etc.) training degree, show assessment, sire, mother, and breeder.

The registration must be signed by the national organization.

6.7. The national organizations must inform the person in charge of organizing the World Championship about the participating competitors by June 01 of the year in question.

6.8. The national organization must send all the registrations with the names to reach the person in charge of the organization of the World Championship by the closing date stated in the invitation.

6.9. Registrations that cannot be considered shall be brought to the notice of the national organization concerned in writing without delay.

## 7. Scorebook

- 7.1. The competitors must show a scorebook issued by their national organization recognized by the FCI. The scorebooks are to be submitted to the organizer together per national organization prior to commencement of the World Championship.
- 7.2. The term "FCI World Championship for Rescue Dogs" must be clearly entered in each competitor's scorebook in addition to the results.

## 8. Classification and title

8.1. The competitor with the highest total number of points in the individual scoring AREA SEARCH shall be the winner and be awarded the title of "20XX (to indicate the date) FCI Rescue Dog World Champion in" AREA SEARCH".

8.1a The competitor with the highest total number of points in the individual scoring TRACKING shall be the winner and be awarded the title of "20XX (to indicate the date) FCI Rescue Dog World Champion in" TRACKING".

8.1b The competitor with the highest total number of points in the individual scoring RUBBLE SEARCH shall be the winner and be awarded the title of "20XX (to indicate the date) FCI Rescue Dog World Champion in" RUBBLE SEARCH".

8.1c The competitor with the highest total number of points in scoring UNIVERSAL shall be the winner and be awarded the title of "20XX (to indicate the date) FCI Rescue Dog World Champion in" UNIVERSAL".

UNIVERSAL= Tracking nose work+ area search nose work+ rubble nose work + obedience and dexterity.

The winners with a minimum qualification of "very good" will be awarded the CACIT and Reserve CACIT. The awarding of the titles is reserved for the breeds subject to a working trial. Reference is made to the special CACIT provisions.

8.2. In the case of a tied score, the highest individual result in nose work shall be decisive then the highest score in obedience and dexterity. In the case of a tied score in the individual sections, the competitors shall be classified in the same position ex aequo.

8.3 All competitors that have achieved a positive result shall be included in the national team score

In the case of a tied score in the national team, the highest score in nose work shall first be decisive. In case the score is still tied, the youngest dog will be ranked first.

The three highest overall results per nation shall be considered.

The team with the highest number of points shall be awarded the title of "FCI Rescue Dog World Team Champion".

In case of a tied score, the total of points in nose work of the three competitors shall be decisive. In the case of a tied score, the national teams will be classified in the same position ex aequo.



- 8.4. The organizing national body shall send the FCI a result list with the names and countries of the competitors. When drawing up the result list, the handlers with their dogs that have achieved the training degree shall be listed first. The other competitors without a training degree shall then be listed according to their score, numbered consecutively in each discipline of the World Championship.

## **9. Prizes**

- 9.1. In the interest of promoting international working dog competitions, it is recommended to the national organizations that the national organization running the World Championship donate a prize for the dog handlers.
- 9.2. A memento prize should be provided for each competitor.
- 9.3. The FCI Rescue Dogs Commission shall be responsible for drawing up rules on the awarding of any challenge trophies. The challenge trophy/trophies shall be handed over by the president of the FCI Rescue Dogs Commission or another commission member nominated by him when the results are announced.

## **10. Protests**

- 10.1 The judges' decision shall be final and incontestable. Objections or protests shall only be possible on account of non-compliance with the rules. Any protest must be lodged with the supervisor (chief judge) by the main team leader. In such case, a guarantee bond of € 300 must be lodged at the same time which shall be forfeited in favour of the FCI Rescue Dogs Commission (FCI account) if the protest is rejected.
- 10.2. The proceedings shall be conducted by the President of the FCI Rescue Dogs Commission (or his deputy). The ruling on protests shall be made by the supervisor, the section judge and the section chairperson. The decision taken by these persons shall be final.

## **11. Insurance**

- 11.1. The organizer must have taken out for the event an insurance policy with sufficient cover for personnel, supervisor, judges and helpers.
- 11.2. Each competitor shall him/herself bear the cost of any damage caused by his/her dog. Each competitor must provide proof with his/her registration application of holding a public liability insurance policy for consequences resulting from being a dog owner.
- 11.3. The local veterinary provisions must be observed.

## **12. General remarks**

- 12.1 The provisions set down in the *International Trial Rules of the FCI and the IRO for Rescue Dogs Tests* must be adhered to strictly and precisely.

- 12.2 In cases of doubt and matters concerning the World Championship which are not provided for in these specifications, the president of the FCI Rescue Dogs Commission shall make the final decision together with the respective trial judge and the supervisor (chief judge) appointed by the Commission.
- 12.3. An invitation is to be given to the president of the FCI Rescue Dogs Commission by the organizer of the World Championship, with the associated costs borne by the organizing national body.
- 12.4. The members of the FCI Rescue Dogs Commission shall have free entry to all the event. Facilities of the FCI World Championship.

### **13. Meeting of the FCI Rescue Dogs Commission**

- 13.1 The FCI Rescue Dogs Commission shall meet at the place of the World Championship after the World Championship.
- 13.2 The person in charge of organizing the World Championship or the organizing national body shall be obliged to provide a suitable seminar room for such a meeting.
- 13.3. The costs of the room and the interpreters shall be borne by the national organization running the event.
